## Electronic Funds Transfer – Making Giving Easier

Historically, the collection envelope has been the accepted method of parish giving. Recently, many parishes now offer the option of electronic funds transfer (“EFT”) for those parishioners who are comfortable with paperless transactions such as direct deposit of paychecks and banking by computer. EFT is a beneficial method of paying Offertory commitments for both the church and the parish family, for several reasons, including:

- There are no checks to write, no checks to remember, and no checks get lost.
- The parish saves money because EFT reduces bank cost.
- Offertory record keeping is more accurate, because we get monthly statements.
- Even the best-intentioned parishioners can forget a check now and then. EFT means that the parish receives your commitment regularly.

Most importantly, the spirit of giving is very much alive with EFT. The act of giving is made when you decide what your commitment to the parish will be for the year. EFT is just the means for carrying out your wish. Prayerful discernment of your Offertory gift remains the most important part of the giving process. The act of giving remains a special opportunity to promote the grace of sharing our God-given gifts with your family and children. Our children are growing up in an electronic era, and giving by EFT will probably be unremarkable to them. What is still essential is that our children come to know that giving to support their church, with time, talent and treasure, is something we Catholics are called to do.
